2024 DLA ENERGY WORLDWIDE ENERGY CONFERENCE (WWEC) RECAP

We extend our heartfelt thanks to everyone who joined us for the DLA Energy 2024 Worldwide Energy Conference (WWEC) from April 22-24, 2024!

This year's conference, held at the Gaylord National Hotel and Convention Center, marked a significant return since our last event in 2019. We were thrilled to host over 2,000 attendees and 90+ exhibitors from the energy industry.

This 2024 event made a successful return after being postponed due to the pandemic. It brought together a diverse group including over 300 U.S. Military personnel, 900 DLA employees, 600 industry representatives, and 100 DoD and other government employees. We were also honored to welcome delegates from 10 allied nations: Australia, Bahrain, Canada, Greece, Italy, Jordan, Oman, Spain, Turkiye, and the United Kingdom.

The conference centered on the critical role of partnerships across the energy supply chain, providing a dynamic platform for dialogue on key energy issues affecting both industry and consumers. With 63 unique sessions, 10 tracks, and 75 speakers—both internal and external—the 2024 WWEC was a testament to our ongoing commitment to fostering collaboration and innovation.
