SAFER FEDERALWORKFORCE

President Biden's announcement that federal employees will need to be vaccinated against COVID-19 or subject to regular testing and certain restrictions in the workplace was released July 29. The new guidance is outlined on the <u>Safer Federal Workplace website</u>.

DLA is in a holding pattern and awaiting guidance from the Department of Defense and the Office of Personnel Management.

In the interim, DLA Energy leadership team is continuing to monitor the situation and study the ways to ensure a safe and methodical return of the workforce to headquarters based on the latest J1 information and acknowledging the new guidance from the White House to the Executive Branch agencies.



The surest way to protect yourself and your loved ones is to <u>GET VACCINATED</u>

DLA employees are authorized up to four hours of administrative leave per COVID-19 vaccination during work hours, and additional time may be granted for recovery as needed. Employees can voluntarily <u>self-report their vaccination status using the DLA CACprotected survey platform.</u>

Updated Masking Guidelines

IT ALERT: Internet Browser Authentication

Having a hard time loading .com websites on your government computer? Here's why...

J6 is implementing DISA's Cloud-Based Internet Isolation (CBII) to protect users from potential phishing attempts/ malicious .com Internet links.

Starting Aug. 10, 2021, all employees will be using CBII.

To open a .com site, you must use your **Authentication** certificate.

!!! HQC Mask Update !!!

As of Aug. 3, a mask is required for all personnel inside the McNamara Headquarters Complex regardless of vaccination status.



Fairfax County has moved to a "substantial" level of community transmission of COVID-19 per <u>CDC</u>. In accordance with <u>DoD guidance</u>, masks must be worn in areas of high or substantial transmission.
