Mr. Broderick served as the served in various capacities within DLA Energy during his military and federal civilian career. His achievements over the course of his 42-year career with the U.S. government, 12 years of which were with DLA Energy as a civilian, notably as the director of Business Process Support Directorate.

Ms. Manley began her distinguished career with DLA Energy in 1984. Her 26-year career began initially as a supervisory contracting officer in the Direct Delivery Fuels Ground Fuels division, ending in 2010, as associate director of the Office of Small Business Programs.

Class of 2021 Lee Oppenheim Martin Harty

Mr. Oppenheim distinguished himself as the premiere Energy technical expert with DLA from 1976 to 2018 in the Quality Technical Directorate. His distinguished 42-year career with the federal government culminated as the Quality Technical Directorate Deputy.

Mr. Harty served as the DLA Energy General Counsel from 1975 to 1988 where he guided the agency through the unprecedented volatile petroleum marketplace of the 1970-1980s including implementing regulations under the Emergency Petroleum Allocation Act of 1973 and the National Strategic Petroleum Reserve. Harty went on to serve as the Deputy General Counsel (Logistics) in DLA Headquarters, 1988-1990.

Induction into the DLA Energy Hall of Fame acknowledges the vital role people play in DLA Energy's current and long-term success. It honors and preserves their exceptional service, dedication, and contributions.

Current and new generations of employees should look upon the inductees as role models and inspiration to motivate them to continue their stellar support to the Warfighter.

- **SIGN OUT**: Employees should SIGN OUT (NOT shut down) their computers at the end of the workday. Important updates are pushed off hours and computers that are turned off will not receive these updates. Once the computer is turned back on, updates may slow the machine down or cause problems with operation.
