## A MESSAGE FROM THE DEPUTY COMMANDER Mr. Dave Kless

As we dive into 2022, I'm excited and looking forward to tackling new projects. We have a lot on our plates but together, as a team, we can accomplish anything.

Congratulations to the DLA Energy Aerospace and Finance team on their new operations facility on Joint Base San Antonio-Lackland! The Commander hosted a ribbon cutting ceremony Jan. 7 welcoming the 104 employees to their new workspace. The team is expected to begin moving in late February after IT equipment is installed.

In December, DLA Energy Americas attended the 23rd World Petroleum Congress in Houston. Considered the industry's most prestigious event, the Congress is a catalyst for crucial conversations with key global leaders and helps DLA Energy gain a better understanding of the future of the Petroleum industry and its vulnerabilities.

To increase safety against COVID-19, a new Force Health Protection Guidance for protecting all personnel in DoD workplaces was signed Jan. 6, 2022. We are working to ensure sufficient COVID-19 test kits are purchased and disseminated to supervisors. Currently, there have been no changes or updates to the vaccine exemption guidance. The exemptions are currently under review, once the deciding official decides on each case, the employees will be notified, via a signed memo.

With a continued focus on Red Hill, the TRANSCOM visit to DLA, and looking ahead to our Joint Petroleum Week currently scheduled for Feb. 7-11, it's already clear that 2022 is shaping up to be challenging and exciting.

## DLA issued cellular service

The [DLA Wireless Device User Agreement](#) requires certain guidelines be met to maintain a DLA issued cellular device.

- You must actively use the device during a 60 consecutive calendar day period.
- All DLA devices must be enrolled in a government managed Mobile Device Management (MDM) system, which was originally configured on your device.

Cellular service will be terminated if you do not check in or use data/voice services for 60 consecutive calendar days. You will also be required to return the device.
