

Why is this important? There are significant changes to many plans for 2023. Several plans will see benefit and rate changes, some plans are dropping out of the program and others are changing their service areas or coverage options.

What do you need to do? Compare plans using the FEHB Plan Comparison Tool. Employees should review, enroll, cancel or make changes to their Federal Employee Health Benefits (FEHB), Flexible Spending Accounts (FSA), and Federal Employees Dental & Vision Insurance Program (FEDVIP) benefits.

**How do you make the changes?** Use the Government Retirement & Benefits (GRB) Platform. GRB is the puts you in control of your election, eliminates possible errors, and allows you to print a confirmation. In GRB, you can also review and make changes to your TSP contributions.

The FSAFEDS Health Care Flexible Spending Account (HCFSA) is an easy way to save money on items and services you already buy. Use the calculator below to estimate your annual, out-of-pocket health care costs, including eligible over-the-counter items, and see just how much you could save by enrolling in the HCFSA. If you need a little help, take a look at the eligible expenses list. Sign up for savings with FSAFEDS!

NOTE: You can only enroll in FSAFEDS during the Federal Benefits Open Season, your new hire election period, or if you experience a

FSAFEDS allows you to set aside pre-tax funds to pay for eligible out-of-pocket dependent care and health care expenses. Remember: If you are currently enrolled in the FSAFEDS program, your election DOES NOT carry over from year to year. If you wish to participate again you will need to make a new election for 2023.
