#### Energy team,

It's been so great to finally travel a bit and meet many of you in person. There is certainly a lot going on across DLA Energy and around the world. From Red Hill to the Ukraine situation, I am proud of all you are doing to ensure Warfighter readiness.

After careful consideration of the current global environment and with the health and well-being of the workforce in mind, Mr. Kless and I made the difficult decision to postpone the 2022 DLA Energy Worldwide Energy Conference that was scheduled for March 28-30, 2022. The next WWEC is on the calendar for 2024, but we will continue to search for an earlier date if time and conditions permit.

As announced, DLA has paused implementation and enforcement of the COVID-19 vaccination requirement for civilian employees, as well as processing and adjudicating requests for vaccine exemptions based on medical or religious grounds, since the federal judge issued an injunction against further implementation of Executive Order 14043. In January 2022, Congress authorized The National Defense Authorization Act for Fiscal Year 2022. I have stood up an Energy operational process team to assist in implementing the required actions to comply with the NDAA requirements. We will continue to provide updates as this effort progresses.


