A MESSAGE FROM CHIEF OF STAFF Col Keith Mecham

Energy Team,

As your Chief of Staff, I feel it is important to personally remind you of your obligation to safeguard sensitive documents and information.

I am sure you are aware of the recent unauthorized disclosure of what appears to be classified DoD and Intelligence Community documents. I would like to remind you that we must abide by official classification markings on any documents and handle them with appropriate protections. This is true even when such documents have been posted online or reported by civilian media. Broad disclosure does not mean the material is declassified. While you may be curious as to what was released, do not access or download documents with classified markings from unclassified websites - either from home or work. It is in our agency's and the nation's best interests to avoid searching the internet for this information. Advances in artificial intelligence can capture search trends, and you could exacerbate the problem.

Personnel with access to classified information are trusted stewards of that information and the responsibility to safeguard classified information is a lifetime requirement for everyone granted a security clearance.

DLA Intelligence Information Security and OPSEC teams are available to discuss protection of information. <u>Use this contact sheet to learn about your representative (CAC-required)</u>.

The information we handle has a direct effect on the lives and safety of our warfighters and it is up to us to ensure it is secured ALWAYS.

Upcoming events highlighted included the DLA Energy Springfest scheduled for May 17 at Fort Hunt Park in Alexandria, Virginia; the DLA Energy Senior Leader Offsite scheduled for May 18-19; and the DLA Energy Commander Change of Command scheduled for June 29 followed by Brig Gen Canlas' retirement on June 30.

One focus area discussed is the future of work, or Line of Effort 5. In February 2023, the DLA Energy directors were asked to review their mission requirements and submit proposed work schedules. Brig Gen Canlas explained they were asked to look at their business units or commands through a different lense and examine their work with the national defense strategy in mind, taking lessons learned from COVID and analyze how DLA Energy needs to organize in order to support the next fight.

Going forward, the DLA Future of Work Working Group continues to meet monthly and is currently discussing MSC implementation of in-office and telework plans and any trends or concerns they are experiencing.




<u>Historic fuel storage facility</u> receives new owner
