SUPPORT COMPLEXITY

- Support to 5 COCOMs: EUCOM, AFRICOM, CENTCOM, TRANSCOM, and SOCOM
- Strategic enabler to EUCOM, AFRICOM, and NATO
- Over 475M gallons of storage
- 57 DFSPs, 65 into-plane locations, 17 bunker sites
- FY19: supported 39 exercises in two COCOMs
- FY20: supported 14 exercises through COVID-19

Customer Operations (OPS Center)

- Coordinate with EUCOM/AFRICOM JPO for exercise and contingency fuel support
- Facilitate and synchronize communication flow between Service Components, JPOs, HQ DLA-E, and RSOC

International Agreements (IA)

- Acquisition alternative to Contracting
- Establishes Mil-Mil bi-lateral international fuel agreements using Acquisition Cross-Servicing Agreement (ACSA) Authority
 - ACSA Orders under COCOM ACSA
- Provides day-day execution and oversight of all agreements within E&A
 - Fuel Exchange Agreements (FEA)
 - Fuel Support Agreements (Pipeline/Depot)

Inventory Management (IM)

- Manage Bulk Petroleum Procurement
- Manage the Inventory Management Plan
- Supply and Demand Planning
- Inventory Accounting
- Manages Defense Fuel Supply Points
- Tanks/Pipelines in/out service status
- Tanker resupply scheduling

Transportation

- Initiate & negotiate Special Service Tenders
- Process Customs Clearances
- Arrange Diplomatic Clearances for carriers
- Schedule JP8 Shipments for Europe DFSPs
- Inspect carrier equipment & credentials at point of sale
- Review, process, and certify invoices for payment

Quality/Lab

- Administer DLA Energy contract quality assurance and surveillance program on all petroleum products procured, shipped, stored and issued to U.S. Forces throughout Europe, Africa, former Soviet Block nations, the Balkans and Turkey (104 countries)
- Provide timely & accurate fuel product testing services in support of DLA Energy customer operations
- Receive approx. 2,000 samples/year
 - Routine QS during storage/use
 - Possible contamination issues
 - Secure Fuels (Presidential Support)
- Support unit training requests on as needed basis
- 1 of 5 DLA Energy Area Labs worldwide

Contracting

- Serves as the technical expert and advisor to the command, customers, and contractors of DLA Energy for all things contracting
- Liaise with Energy HQ contracting offices to ensure the Region's priorities are addressed in a timely manner
- Liaise with host nation officials to gain tax/exercise exemptions
- Coordinate and attend pre-proposal and post award conferences
- Supplier relationship management

Customer Account Specialists (CAS)

- Manage Customer Direct fuel orders for DoD Components/ U.S. Embassies throughout the Europe/Africa AOR
- Ensure customers process invoices (via WAWF/ PIEE)
- Assist customers with DLA Forms and systems related issues: TSW, EEBP, WAWF, DIBBS, DAASING and CIS
- Research and resolve Blocked Invoices, Unliquidated Obligations, and Unfulfilled Customer Orders
- Create offline fuel orders and process manual Goods Receipt (invoices) on customers' behalf
- Responsible for approx. 86 DODAACs
- Average 200 orders per month
