### **Announcing DLA Weapons Support**

The Defense Logistics Agency announced on October 1, 2025 the stand up of a new major subordinate command dedicated to supplying spare and repair parts to the military services. <u>DLA Weapons Support</u> integrates the missions of DLA Aviation and DLA Land and Maritime into a single unified command responsible for weapon systems support to the joint force.

In military terms, this supply category is known as Class IX. Initial operating capability for the new MSC began October 1, 2025, and it will operate across the two existing locations at Defense Supply Center Columbus, Ohio, and Defense Supply Center Richmond, Virginia. No facility closures are planned.

DLA Director Army Lt. Gen. Mark Simerly called this an exciting time for DLA, as it rewrites the script on weapon system support.

"Nobody else can do what we do, and we're not going to back down from that mission set," Simerly said, noting the outstanding quality and adaptability of the Class IX team is unrivaled in meeting the needs of the warfighter.

The commanders of the former MSCs – Navy Rear Adm. Julie Treanor at Land and Maritime, and Air Force Brig. Gen. Patrick Launey at Aviation – will share command responsibilities during the one-year transition period.

"We have a unique opportunity to challenge existing norms and make this organization the best it can be," Treanor said. "This unified command will significantly enhance our support in today's highly contested operational environment and enable us to move faster, think smarter, and respond more effectively to evolving warfighter needs."

### **Announcing DLA Weapons Support (Cont.)**

Echoing Treanor's vision, Launey said the transformation will not only benefit the warfighter but also strengthen the organization's internal cohesion.

"This transformation allows us to re-evaluate how we're structured, how we operate, and how we communicate – always keeping the warfighter, our suppliers, our workforce and the Agency's overall mission in mind," Launey said. "We have amazing teams of logistics professionals who are committed to growing even stronger and more effective as we move out on this campaign together."

Simerly said that when DLA leadership was looking at the agency's organizational structure, it made sense to combine the Class IX spare and repair parts mission under one umbrella, to have "a single command to optimize our level of support, develop standard best practices and prioritize appropriately across the board."

"As the nation's logistics combat support agency, it is vital that DLA evolves in parallel with the everchanging landscape," he said. "Now is the time to accelerate transformation – modernizing DLA to be more adaptive, efficient and resilient."

This change is part of several transformative initiatives to increase effectiveness, enhance support to the warfighter and optimize DLA's workforce. It also directly aligns with the War Secretary's priorities to restore the warrior ethos, rebuild the military and reestablish deterrence.

Simerly emphasized the plan for the new MSC was "integrated by design," reflecting the combined efforts of both the DLA Land and Maritime and DLA Aviation leadership.

An integration team that includes key leaders and support staff from DLA Aviation, DLA Land and Maritime, and DLA Headquarters was assembled to inform the design of the new MSC.

The establishment of DLA Weapons Support is a long-term investment in the future of DLA. The new MSC is designed to be a more efficient, effective and resilient organization capable of meeting the challenges of the future. As stated in its mission statement, DLA Weapons Support will deliver "Weapon Systems readiness and lethality globally to our Warfighters, the Nation, and its partners."

Regular updates to the workforce and the agency's customers will be announced as decisions are finalized and implementation progresses.

Simerly harkened back to the agency's beginnings to drive the point home that DLA is built to change and built to last, and this latest transformation is an evolution of DLA's collective DNA.

"We think the things that made us valuable then, very much hold true now," he said. "We have expanded, and we have contracted over time as we responded to warfighter requirements — constantly changing to meet the needs of those who depend on us."

Some of the key ways APEX Accelerators help businesses are:


- Assistance in completing registration with a wide range of databases necessary for participation in the government marketplace (e.g., DIBBS, SAM, etc.).

In order to enhance information security, DLA updated the DIBBS user terms and conditions on 10/9/2025. Since that date, all DIBBS registered users are prompted to accept the new terms and conditions the next time they log into the system. ## What's In a Name: Joint Certification Program (JCP)?

What It Is: The Joint Certification Program Office (JCO) oversees the eligibility process for accessing Export Controlled Data. It manages the submission and approval of Militarily Critical Technical Data (DD2345) forms for U.S. and Canadian vendors seeking access to Defense Logistics Agency (DLA) and Military Services (MIL SVC) controlled data. The JCO handles both standard applications and those requiring DLA Enhanced Validation (DEV).

A Brief History: Established in 1985 through a Memorandum of Understanding (MOU), the JCP began as a fully manual process—complete with rubber-stamped signatures and paper-based correspondence. Until our larger technological transformation in 2023, incomplete registrations were returned via traditional mail (or fax), making the process slow and cumbersome.

Today, the program has evolved into a streamlined, web-based system. Upon completion, applicants receive an auto-generated DD2345 form via email. This modernization has significantly enhanced support for DoD and DLA acquisition efforts, enabling secure access to technical data for solicitations, conferences, and scientific research.

**Basic vs. DEV Registration:** To access DLA's Export Controlled Technical Data via cFolders, vendors must be registered with both the Defense Internet Bid Board System (DIBBS) and the DLA Enhanced Validation (DEV) certification. Solicitation packages will specify whether DEV registration is required—so it's essential to carefully follow the instructions provided in each solicitation.

- Prerequisite for DEV DD2345 Registration: Before applying for DEV certification, vendors must hold an active
   DD2345 registration. That's right DD2345 is a mandatory first step. Without it, DEV registration cannot proceed.
- Submitting a DEV Application:
  - When submitting a DLA Enhanced Validation (DEV) request:
  - Include a copy of your active DD2345 form with the application
  - Ensure your Joint Certification Program (JCP) registration is current and valid
  - Applications missing an active DD2345 will be rejected.

### When to Register:

Before applying to the JCP, vendors must:

- Be registered in the System for Award Management (SAM)
- Possess a valid Commercial and Government Entity (CAGE/NCAGE) code
- Complete a cybersecurity self-assessment per NIST SP 800-171
- Review and complete the Introduction to Proper Handling of Export Controlled Technical Data training

#### **Additional Registrations That May be Necessary**

- Directorate of Defense Trade Controls (DDTC): If your products are listed on the United States Munitions List (USML)
- Commerce Control List (CCL): If your items fall under the jurisdiction of the U.S. Department of Commerce's Commerce Control List

### **Packaging and Marking Discrepancies**

Packaging, palletization, and marking/labeling discrepancies cause a considerable delay in payment of invoices, goods receipt and delay the availability of material to the Warfighter. In 2018, DLA began automatically notifying suppliers of materiel arriving with packaging and/or marking that is not contractually compliant. As part of a Continuous Process Improvement (CPI) initiative, an enhanced notification letter includes links to a series of informational videos that provide a representation of what 'right' looks like.

Common errors addressed in the short videos are:

- Unit/intermediate and exterior item <u>identification markings</u>
- Military shipping labels proper addressing in the Vendor Shipping Module (VSM)
- Packaging preparation for delivery and packaging requirements
- Pallet types types of pallets used by DLA, correct use and preparation
- Shelf life how to handle materiel with a shelf life like batteries or tires
