#### DLA Internet Bid Board (DIBBS) and Collaboration Folders (cFolders) Terms of Use

When access is granted to DIBBS and cFolders, DLA relies on users to follow the DIBBS and cFolders Terms of Use to help maintain the integrity of these systems. When users do not comply with the terms of use they risk having their DIBBS and cFolders access temporarily denied or indefinitely suspended. To avoid disruption in accessing these systems, which are closely monitored by DLA as part of its cyber security, DLA highly encourages users to read their "Super User and Subordinate User Terms and Conditions for Accessing DIBBS" and the "Warnings" listed on the splash page when accessing cFolders at <a href="https://pcf1.bsm.dla.mil/cfolders">https://pcf1.bsm.dla.mil/cfolders</a>. #### **Top 10 Avoidable Packaging and Marking Problems**



DLA recently conducted a review on contractor errors related to packaging, marking, and labeling. The following are the Top 10 avoidable problems:

#10 Shipping material before the DCMA quality assurance representative inspects and signs acceptance (inspection and acceptance at origin/source)

#9 Shipping documents missing, incomplete, or illegible

- #8 Electrostatic sensitive material shipped in non-conforming packaging
- #7 Shelf-life markings omitted or incorrect
- #6 Special markings specified in the contract omitted
- #5 Not packaged to the quantity unit pack (QUP) specified in the contract

#4 Incorrect packaging and marking of the unit of issue specified in the contract

- #3 Non-conformance to wood packing material requirements
- #2 MIL-STD-129R labels omitted or incorrect on packaging
- #1 MIL-STD-129R labels missing required elements





The DLA packaging website contains useful links, FAQs, videos, and additional information on Electrostatic Discharge Sensitive (ESDS) items, palletization, commercial packaging, labeling, and other packaging related topics. It also contains a packaging and marking guide for use by suppliers to assist with understanding contract marking and packaging requirements, which will help prevent discrepancies at time of receipt. ### **CHANGE IN KO SIGNATURE**

Beginning October 25, 2021, the contracting officer signature appearance on manually generated contract actions changed due to modern web browser requirements. The contracting officer signature will appear in a simple cursive style instead of showing as a Common Access Card applied digital signature. The signature format is valid for all DLA contracting actions and examples are provided at:

#### Reminder to DLA Suppliers: NIST SP 800-171 ASSESSMENTS AND EXPORT-CONTROLLED TECH DATA

Export-controlled technical information is Controlled Unclassified Information (CUI)/Controlled Technical Information (CTI). DLA suppliers seeking export-controlled technical data for DLA procurement opportunities must have a current National Institute of Standards and Technology (NIST) Special Publication (SP) 800-171 cybersecurity assessment (i.e., not more than 3 years old unless a lesser time is specified in the solicitation) posted to the DoD Supplier Performance Risk System (SPRS) to be considered for award. **DLA Suppliers who currently have an approved Enhanced Joint Certification (JCP) but have not posted their NIST SP 800-171 assessment to SPRS will not be able to access export-controlled technical data in DLA's technical data repository.
