Goodbye CORT Tool and Hello JAM and SPM

CORT Tool Decommissioned, Welcome JAM

Contracting Officer Representative (COR) nominations and appointment process is moving to the Joint Appointment Module (JAM).

JAM will:

- o centralize and improve management of official appointments impacting enterprise-wide procurement systems, procurement related appointments.
- be used to appoint Contracting Officer Representatives (CORs) starting with the PIEE 6.0.0 release.
- o support an appointment process initiated by either the COR or the Contracting Officer/ Specialist and result in a digitally signed, electronic appointment letter.
- CORs will be electronically nominated and appointed on one or many contracts using JAM.
- All appointments must be initiated, reviewed, approved, signed, stored and terminated in the JAM module within PIEE.

Surveillance and Performance Monitoring (SPM) is Born

The COR's Online File will now be part of the Surveillance and Performance Monitoring (SPM) Module in PIEE:

- SPM will facilitate COR management, oversight, surveillance, and performance monitoring.
- All individuals, performing contract surveillance will have access to and use of this capability.
- All other COR and contract surveillance functions will be performed in SPM.
- SPM will provide the visibility and accountability necessary for leaders to manage the thousands of CORs assigned throughout the Department.
- SPM provides contracting and COR personnel a web-based portal for all relevant COR actions.
- COR management must review the COR surveillance and monitoring activities when evaluating the COR performance via the SPM Module in PIEE.
- Recurring surveillance data will capture via Hypertext Markup Language (HTML)
