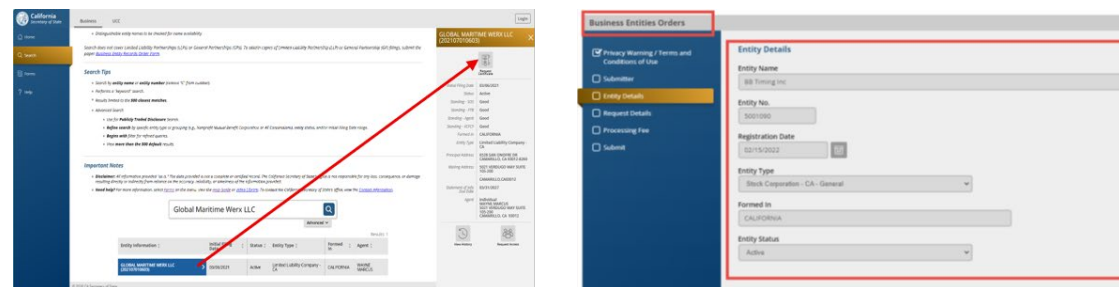

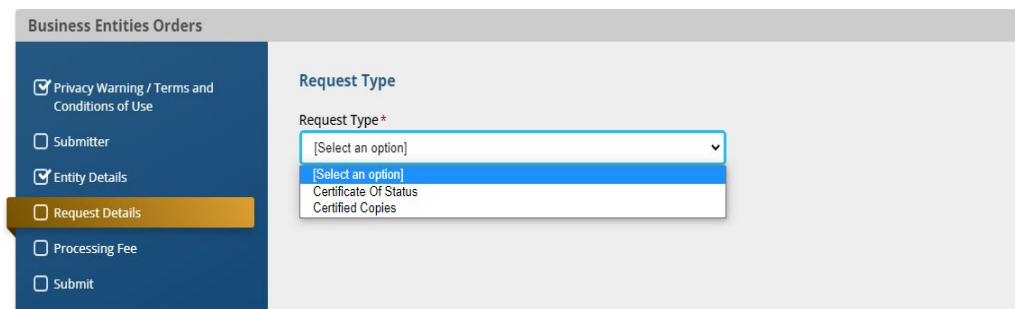

A user must be Logged In to order Certified Copies and Certificates of Status for Business Entities.

- The user must run a Business Search to find the correct entity.
 - If the user has Full Access or Basic Access to the online entity record, the user can navigate to their My Business Records on the left navigation pane.
 - Both paths will take the user to the public entity record.
- Once the entity record is selected, the right navigation drawer will open.
 - Select the Request Certificate button at the top of the right-hand navigation pane.
- This will take the user to the Business Entities Orders wizard, first page Privacy Warning /Terms and Conditions of Use.
