DLA TS C&T Additional Quality Assurance Requirements Updates (Formerly DPSCM 4155.3)



- DLA Troop Support Clothing and Textiles Additional Quality Assurance Requirements dated October 2018 (Formerly DPSCM 4155.3)
 - Contract modifications this year with an interim change to the AQAR was necessary to align with DCMA's new policy to refocus their efforts on mission critical weapon system support.
 - In lieu of DCMA Quality Assurance Specialist sampling rolls of fabric for shade or physical evaluation, the cloth manufacturer may choose a representative from their company, referred to as "Supplier's Source Sampling Representative" in the interim change to perform that duty.
 - Swatch sampling by Supplier's Source Sampling Representative does not relieve the cloth supplier or the prime contractor any test or evaluation requirements, it simply changes who draws the samples and signs off on the DD1222.
 - There are infrequent instances of which the DCMA QAS will still sample swatches and sign off on the DD1222. DLA will coordinate with DCMA and the contractor when this is required.
 - The interim change to the AQAR only applies to contracts that require sampling for shade or physical testing. If this is testing is not a requirement of the contract, the change is not applicable.
 - Any questions as to whether or not a particular contract requires this testing, please contact your Contracting Officer.

Technical Data



- Technical data for Clothing and Textile items DLA procures varies depending on the item being procured but may include: drawings, specifications, standards, purchase descriptions, patterns, standard sample swatches, supplemental quality assurance requirements.
- Vendors are urged to request tech data for each acquisition as requirements do change. Many older documents are also in the process of being revised, so be sure to check if a new revision is available.

Distribution Statements



- DoDI 5230.24 (dated August 23, 2012 Incorporating Change 2, Effective November 1, 2017) requires all newly created, revised, or previously unmarked classified and unclassified DoD technical documents (PDs, drawings, supplemental QA provisions, etc.) be assigned a distribution statement.
- All DoD Components generating or responsible for technical documents shall determine their distribution availability and mark them appropriately before primary distribution. Any technical documents coming to DLA require these markings.
- Without a distribution statement, DLA is not authorized to release the technical documents outside of our organization.
- Distribution statements shall be shown on the title page or front cover and the most restrictive distribution on its parts of the document governs the document's distribution as a whole.
- Distribution statements currently available are A, B, C, D, E, and F. Wording of the distribution statement is standard and should not be altered except to insert the specific Authorized audience, Reason for control, Date of determination, and Controlling office in distributions other than A.
- Example distribution statement:

"Distribution statement A. Approved for public release: distribution unlimited"
