




Organizational Clothing Material Obligations FY2022-FY2024








Organizational Clothing Material Obligations FY2024 Planned vs. Actual

Past Performance

- Supplier Performance Risk System (SPRS):
 - Your SPRS Delivery Score is reviewed for award decisions. Vendors should review their Negative Delivery Records for accuracy. If a Due Date is incorrect, if a Ship/Rec Date is missing or wrong, or if late shipment was due to government delay contact timothy.atwell@dla.mil for assistance. Tim Atwell is always available to help with any questions, concerns or SPRS website access and navigation.
- Delivery date is when the item arrives at the destination.

Tiered Pricing

The tier contract pricing approach embraces the concept of a multi-year ordering period. A Guaranteed Minimum Quantity (Generally 25% of AEQ) applies to the first tier/year only. A single Contract Maximum Quantity (Generally 125% of AEQs) for the life of the contract applies. A Maximum Monthly Quantity and Quarterly Delivery Orders also apply.

Economic Price Adjustment

In general, C&T solicitations do not include an Economic Price Adjustment (EPA) Clause. Prior to solicitation issuance/opening, a market research survey is posted on https://sam.gov which provides the opportunity for any company interested in supplying an end item to state if they would like an EPA clause included in the solicitation. If so, the company is required to provide the index/indices to be considered for the EPA clause and the basic material(s) percentage of end item cost that the PPI will apply to. Please understand that an upward ceiling and downward floor of no more than 10% of the applicable base unit price shall apply.



Product Demonstration Models

- Product Demonstration Models (PDMs) are required to be submitted through traceable means via the U.S. Postal Service or a Commercial Carrier (Example: FedEx, Airborne, UPS, DHL, Emery). In-person delivery of PDMs by offerors is NOT authorized. The Tracking Number shall be provided as part of the DIBBS electronic upload proposal submission.
- PDMs are to be delivered between 8:00 a.m. and 1:00 p.m. E.S.T., Monday through Friday, except for legal federal holidays. Packages must be plainly marked ON THE OUTSIDE OF THE CARRIER'S PACKAGE with the solicitation number, date, and time set forth for receipt of offers. Ultimately, it is the offeror's responsibility to ensure that its PDMs are RECEIVED at the correct location at the correct time. Failure to do so may result in the offeror's proposal being deemed untimely and not considered further for the award.
