## **DLA Troop Support's Construction and Equipment (C&E) Fire & Emergency Services Equipment (FESE)**

**Is Live in VCAL as of *March 31st 2025***

As DLA Troop Support C&E, transitions into the new Enterprise Business Platform titled Vendor Contract Awarded Logistics (VCAL), we want to make this transition seamless. As of Monday, March 31st we are live with the new VCAL, TLS website. Instructions and the website link are provided, detailing how to submit funding for an order through VCAL using the Financial Information Bulk Upload spreadsheet.

### **\*\*Submitting Funding in VCAL\*\***

- You will need to sign in the VCAL website to submit funding using [DLA FES VCAL Website](#).
- The Financial Information Bulk Upload allows you to populate your funding for multi-line orders and then upload into the system.
- All customer POCs to include Financial Point of Contacts (FOPOC) will need to have an approved account in VCAL to view DLA pricing quotes and submit funding.
- Funding types accepted are MIPRs, MILSTRIP and 7600B. Please email [CEGTC@dla.mil](mailto:CEGTC@dla.mil) to confirm whether your service/organization has an agreement in place with DLA and receive a copy.
- When funding with MILSTRIP, funded Requisitions please note the following on Billing Authority (BA)

Signal Code	Supplemental Address	Notes
A	Not Required	First 6 characters of Requisition Number must be the Ship To DoDAAC and have (BA)
B	DoDAAC has (BA)	Supp DoDAAC must have (BA) & First 6 characters of Requisition # is the Ship To DoDAAC.
J	DoDAAC needed	First 6 characters of Requisition # must have (BA)
K	DoDAAC used - Must be Ship To & has (BA)	Supp DoDAAC must have (BA) & Supp DoDAAC is the Ship To. First 6 characters of Requisition # is valid.

**As of Monday, March 31st: All Fire & Emergency Services Equipment (FESE) requirements and associated funding will need to be submitted via the VCAL website.**

### **Frequently Asked Questions & Answers:**

**Q:** How will I know when my price quote is available?

**A:** There are three ways customers will be notified when price quotes are available. 1) Customer Ordering POCs and Finance Office Point of Contact (FOPOC) will both receive an email notification indicating the “*Your Order is Ready for Funding*”. 2) The order stage will state “*Customer Action Required*”. 3) 🟢 indicates the “*Quote Recommendation*” is ready.

**Q:** How long are quotes good for?

**A:** Quotes are usually good for 60 days. If funding cannot be submitted within 60 days, please communicate funding concerns with your Tailored Vendor Logistics Specialist (TVLS).
