- f. The Unique Entity Identifier Number, as referenced on page 4 of the solicitation, was corrected by Truck Country to read and returned to DLA Troop Support on December 12, 2019 and is hereby incorporated into the contract.
- g. The Truck Country's Warranty covers equipment used or operated <u>in</u> the United States (including Alaska and Hawaii) as required on pages 12, 29 and 30 of Solicitation SPE8EC-17-R-0008 and is acceptable to DLA Troop Support and hereby incorporated into the contract. The Contractor's warranty fails to cover equipment used or operated in all areas outside the United States, as required on pages 12 and 29 of Solicitation SPE8EC-17-R-0002. Currently, the Contractor's warranty covers only the following areas outside the United States: Barbados, Bolivia, Caribbean, Chile, Colombia, Costa Rica, Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Nicaragua, Panama, Peru, Puerto Rico, Uruguay, Venezuela, Egypt, Israel, Jordan, Oman, Saudi Arabia, South Africa (PARTS AND SERVICE ONLY), United Arab Emirates, Australia, Guam, New Zealand, Germany, Russia, Denmark, Bahrain, Switzerland, Poland, Hungary, Greece, Austria, Ireland. Therefore, the Contractor is not authorized to provide a quotation in response to any Request For Quote (RFQ) that requires delivery to any other OCONUS location. For purposes of this contract, Alaska and Hawaii are not included as OCONUS locations. If during the period of this contract, the Contractor is able to provide warranty coverage for additional areas outside the United States, the Contractor may request a Modification to this contract revising the quoting restrictions. The request for modification must be accompanied by supporting documentation.
- h. The product base list unit prices set forth in the contractor's proposal dated July 11, 2018, and the final proposal discounts dated December 19, 2019, are applicable to the items specified in this contract and are shown on page 11 of this contract.


