1) CONTRACT AWARD

This contract constitutes the Government's acceptance of the Contractor's offer, including all revisions that were approved and accepted by the Government, under Request for Proposal (RFP) SPE8EC-17-R-0005 and Amendments 0001 and 0002. It is an Indefinite Delivery/Requirements Contract under which SupplyCore, Inc. shall function as a supplier for Construction Equipment.


