- h. Email dated February 26, 2021 from Advanced Material Handling, LLC regarding FAR 52.204-24 Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment (Oct 2020) paragraph (d)(1) and (d)(2) in which they represented they "will not provide" and "does not use" covered telecommunications equipment or services is hereby incorporated into the contract by reference.
- i. The product base list unit prices set forth in the contractor's proposal dated May 21, 2020, are applicable to the items specified in this contract and are shown on page 13 of this contract.

The proposed product base list unit prices are from Advanced Material Handling, LLC's Commercial Price List.

The negotiated discounts on page 13 of this contract shall remain in effect for the entire five-year contract period. The contract pricing (catalog price minus discount) shall be the ceiling price for any delivery order awarded under the contract. At any time, the contractor can offer discounts greater than the contractual discounts.


