1) CONTRACT AWARD

a. This contract constitutes the Government's acceptance of the Contractor's offer, including all revisions that were approved and accepted by the Government, under Requests for Proposals (RFPs) SPE8EC-17-R-0002, as amended by Amendments 0001 through 0005. It is an Indefinite Delivery/Requirements Contract under which the Contractor shall function as a manufacturer/supplier for various material handling equipment.

b. Performance under this contract shall be governed by the Statement of Work (SOW) and terms and conditions of RFP SPE8EC-17-R-0002, as amended, and the following terms and conditions negotiated prior to award that were acceptable to both the Contractor and the Government.

c. Discount Terms of [REDACTED] are acceptable and are incorporated into this contract.

d. Clause Far 52.212-16 Economic Price Adjustment - Standard Supplies "All" are acceptable and are incorporated into this contract.

e. The Commercial Warranty provided by Alden equipment, Inc for Xtreme Manufacturing, LLC. and Alden's confirmation that all solicitation warranty requirements will be met on June 6, 20021 are acceptable incorporated into this contract.

f. On December 30, 2020, Alden Equipment, Inc. provided electronic copies of the commercial catalogue/brochures for each item offered in their proposal which are hereby incorporated into the contract.

g. Alden has certified in SAMS in regarding FAR 52.204-24 Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment (Oct 2020) paragraph (d)(1) and (d)(2) in which they represented they "will not provide" and "does not use" covered telecommunications equipment or services is hereby incorporated into the contract by reference.

h. The product base list unit prices set forth in the contractor's proposal dated December 30, 2020, and the final proposed discounts dated August 6, 2021, are applicable to the items specified in this contract and are shown on page 14 of this contract.

The proposed product base list unit prices are from Xtreme Manufacturing, LLC.'s [REDACTED] Commercial Price List.

The negotiated discounts on page 14 of this contract shall remain in effect for the entire five-year contract period. The contract pricing (catalog price minus discount) shall be the ceiling price for any delivery order awarded under the contract. At any time, the contractor can offer discounts greater than the contractual discounts.

2) CONTRACT PERIOD

Any supplies to be furnished under this contract shall be ordered by issuance of delivery orders by DLA Troop Support. The ordering period shall commence on the date of award/contract and shall continue for five (5) calendar years after the effective date of the award/contract.

The "Total Award Amount" listed in block twenty-six (26) on page one (1) of this contract (\$235,000,000.00) is the estimated value of the five (5) year contract and represents the combined five (5) year value of all Material Handling Equipment contracts to be awarded under SPE8EC-17-R-0002, not this contract alone. The maximum dollar value that may be obligated against the contract throughout the five (5) year contract period is \$400,000,000.00.

3) DELIVERY ORDER LIMITATIONS

(a) **Minimum Order:** When the Government requires supplies or services covered by this contract in an amount of less than one each, the Government is not obligated to purchase, nor is the Contractor obligated to furnish those supplies or services under the contract.

(b) **Maximum Order:** The Contractor is not obligated to honor -

(1) Any order for a single item in excess of \$100,000,000.00

(2) Any order for a combination of items in excess of \$100,000,000.00; or

(3) A series of orders from the same ordering office within five (5) days that together call for quantities exceeding the limitations in subparagraph (b)(1) or (b)(2) of this section.

(c) The Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within thirty (30) days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

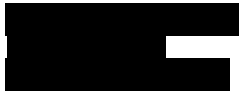
