**SupplyCore Inc. (SupplyCore)****1) CONTRACT AWARD**

a. This contract constitutes the Government's acceptance of the Contractor's offer, including all revisions that were approved and accepted by the Government, under Request for Proposals (RFPs) SPE8EC-17-R-0002 as amended by Amendments 0001, 0002, 0003, 0004 and 0005. It is an Indefinite Delivery/Requirements Contract under which the Contractor shall function as a supplier for Material Handling Equipment (MHE).

b. Performance under this contract shall be governed by the Statement of Work (SOW) and terms and conditions of RFP SPE8EC-17-R-0002, as amended, and the following terms and conditions negotiated prior to award that were acceptable to both the Contractor and the Government.

c. The Place of Performance – Government Inspection, Acceptance and Shipping Point certification requirement, which was completed by SupplyCore and returned to DLA Troop Support on July 15, 2021, is hereby incorporated into the contract, and shown on page 6.

d. FAR 52.204-24, Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment (OCT 2020), which was completed by SupplyCore and returned to DLA Troop Support on July 15, 2021, is hereby incorporated into the contract.

DFARS 252.204-7016, Covered Defense Telecommunications Equipment or Services— Representation (DEC 2019), which was completed by SupplyCore and returned to DLA Troop Support on July 20, 2021, is hereby incorporated into the contract.

e. The revised Letter of Commitment from Skylift Inc. to SupplyCore dated October 27, 2020, which was returned to DLA Troop Support on August 19, 2021, is hereby incorporated into SupplyCore's proposal.

f. The product base list unit prices and the final proposal discounts dated September 29, 2021, are applicable to the items specified in this contract and are shown on page 15 of this contract.

The product base list unit prices are from Skylift Inc.'s [REDACTED] Commercial Price List.

The negotiated discounts on page 15 of this contract shall remain in effect for the entire five-year contract period. The contract pricing (catalog price minus discount) shall be the ceiling price for any delivery order awarded under the contract. At any time, the contractor can offer discounts greater than the contractual discounts.

g. The revised delivery schedule of 210 days after the date of order for all contract items, as referenced in correspondence from SupplyCore to DLA Troop Support on July 28, 2021, is acceptable and hereby incorporated into the contract as shown on page 15.

h. In performance of this contract, any transportation of supplies by sea must comply with DFARS 252.247-7023, Transportation of Supplies by Sea – Basic (FEB 2019).

## **2) CONTRACT PERIOD**

Any supplies to be furnished under this contract shall be ordered by issuance of delivery orders by DLA Troop Support. The ordering period shall commence on the date of award/contract and shall continue for five (5) calendar years after the effective date of the award/contract.

The “Total Award Amount” listed in block twenty-six (26) on page one (1) of this contract (\$235,000,000.00) is the estimated value of the five (5) year contract and represents the combined five (5) year value of all Material Handling Equipment contracts to be awarded under SPE8EC-17-R-0002, not this contract alone. The maximum dollar value that may be obligated against the contract throughout the five (5) year contract period is \$400,000,000.00.

## **3) DELIVERY ORDER LIMITATIONS**

- (a) **Minimum Order:** When the Government requires supplies or services covered by this contract in an amount of less than one each, the Government is not obligated to purchase, nor is the Contractor obligated to furnish those supplies or services under the contract.
- (b) **Maximum Order:** The Contractor is not obligated to honor -
- (1) Any order for a single item in excess of \$100,000,000.00
  - (2) Any order for a combination of items in excess of \$100,000,000.00; or
  - (3) A series of orders from the same ordering office within five (5) days that together call for quantities exceeding the limitations in subparagraph (b)(1) or (b)(2) of this section.
- (c) The Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum order limitations in paragraph (b) of this section.
- (d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within thirty (30) days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.
