I. The purpose of this amendment is to eliminate the Small Business Set-Aside for Group I and III. Group I, II, and II are being solicited as unrestricted with HubZone Evaluation Preference. The statements in page 3, 7, and 19 shall read as follow:

a. This procurement is being solicited under the Federal Acquisition Regulations ("FAR") subpart 13.5 - Test Program for Certain Commercial Items. Solicitation SPE30017R0034 is designed to place Market Ready Fresh Milk and dairy items, all fully competitive, on contract(s) for various Department of Defense ("DoD") customers.

b. The resultant contract will be issued as a firm-fixed price IQC with EPA applied to Class I fluid milk items and firm fixed price with two pricing tiers for all other items for the entire term of the contract.

c. The contract period is expected to be from June 25, 2017 to June 20, 2020. Tier 1 will be from June 25, 2017 to June 22, 2019. Tier 2 will be June 23, 2019 to June 20, 2020.

d. Group I, II, and II are being solicited as unrestricted with HubZone Evaluation Preference.

II. This amendment extend the solicitation closing date to Tuesday, June 13, 2017 at 3:00 PM EST.
