The Guaranteed Minimum contract dollar value is \$1,785,850.00 and the 300% Maximum contract dollar value is \$267,877,500.00. The guaranteed minimum and maximum, although based on estimates, are a firm dollar amount calculated as a percentage of the estimated dollar value. The guaranteed minimum constitutes the Government's legal ordering obligation under the contract.

The 24 Month (1<sup>st</sup> Base Tier) Estimate is \$35,717,000.00 and the 5 Year (All Tiers) Estimate is \$89,292,500.00. The term "5 Year Estimate" refers to the Government's good faith estimate of the requirement for all Tier periods.

provision during the contract period inclusive of any tier period(s) shall not exceed 90% of the initial delivered price for each contract unit price. The respective percent (%) ceiling for each line item is in effect throughout the entire length of the contract period. To further illustrate this point, Attachment 1 (Final Pricing) includes a separate column that identifies the percentage EPA ceiling for the individual Delivered Prices of each line item on the catalog. This price represents the maximum increase in Delivered Price allowable for the entire 5-year length of the Contract. For additional information, see the EPA provision as specified in the Solicitation.
