Replace with:

The following technical factors will be evaluated: Factor I (Experience), Factor II (Quality Control & Quality Assurance Procedures), Factor III (Food Defense) and Factor IV (Surge and Sustainment).

5. Any reference to the word “vendor” shall be replaced with “contractor,” except when the Prime Vendor program is being referenced.
6. Attachment 1 – SPM300-13-R-0076 Price Proposal 05-01-13 is deleted and replaced by Attachment 1 – SPM300-13-R-0076 05-14-13 to replace item numbers 1, 114 and 128.
