1. The Solicitation Provisions Section, Addendum to 52.212-3 Offeror Representations and Certification – Commercial Items (Aug 2009), Additional Solicitation Provisions, clause 52.245-2 is deleted.

The Statement of Work, Supplies/Services and Prices Section, #17 Government Furnished Material (GFM), paragraph C, Fresh Fruits & Vegetables (FF&V) and Other Perishable Items (Zone III Only), the following is added: When a local source for FF&V is not available, Awardee must use the Defense Transportation System (DTS) to transport FF&V to Kyrgyzstan.
