

Contract SPE30015D3107 and Administrative Contracts SPE30015DA010, SPE30015DA011, and SPE30015DCA02 are hereby modified as follows: This 24 month option period extends the performance period from 10 October 2017 through 9 October 2019. The estimated dollar value for this option period is \$65,931,296.36. The guaranteed minimum for the option period is \$16,482,824.09, 25% of the total estimated dollar value. The maximum dollar value for this contract is \$412,156,481.80, 250% of the total estimated dollar value.
