## I. SOLICITATION/CONTRACT FORM

The terms and conditions set forth in solicitation SPE300-20-R-0005, and the following amendments are incorporated into subject contract:

## II. PERFORMANCE PERIOD:

#### A. Effective Period of the Contract:

Tier 1 – December 29, 2020 through December 28, 2022

Tier 2 – December 29, 2022 through June 28, 2024

Tier 3 – June 29, 2024 through December 28, 2025

Ordering commences on April 5, 2021 with first deliveries beginning April 7, 2021 for Troop customers and April 12, 2020 for School and Reservation customers.

#### B. ESTIMATED DOLLAR VALUE/GUARANTEED MINIMUM/MAXIMUM

All Groups have been awarded together, and therefore, the total 10% Guaranteed Minimum contract dollar value is \$1,100,000.00 and the 300% Maximum contract dollar value is \$165,000,000.00. The guaranteed minimum and maximum, although based on estimates, are a firm dollar amount calculated as a percentage of the estimated dollar value. The guaranteed minimum constitutes the Government's legal ordering obligation under the contract.

The 24 Month (1<sup>st</sup> Tier) Estimate is \$22,000,000.00 and the 5 Year (All Tiers) Estimate is \$55,000,000.00. The term "5 Year Estimate" refers to the Government's good faith estimate of the requirement for all Tier periods.


