The following changes will be made to solicitation SPE-300-22-R-0049 in the issuing of this Amendment effective April 20, 2023:

1. One new Troop Delivery Point was added to Attachment 3 - Delivery Schedule, Group 2 Troops. The delivery point added is as follows: NYNY13,RS Albany USMC.
2. One new subgroup was added to Attachment 3 - Delivery Schedule. The subgroup is as follows: Group 3b Upper New York Reservations East. One customer will be included in this subgroup: ONY944, UPPER NY TRIBES, NY, YIR162, SAINT REGIS MOHAWK TRIBE.
3. One new Schedule of Items sheet was added to Attachment 1 - Schedule of Items R0049. The Schedule of Items sheet added is as follows: Group 3b Upper New York Reservation - E.
4. Page 8 paragraph B of Solicitation SPE30022R0049: "The aforementioned zone is comprised of three (3) Groups in the Upper New York Zone. Group 1 consists of Non-DoD USDA Schools West (1a) and Non-DoD USDA Reservation (1b) customers located in the Upper New York Zone. Group 2 consists of DoD Troop customers located in the Upper New York Zone. Group 3 consists of Non-DoD USDA Schools East. The Agency intends to award one separate contract per Group. Offerors may submit a proposal for any single group or multiple groups. The offeror must support all of the customers in the Group for which they make an offer. In regards to Group 1 (1a and 1b), the offerors must submit bid proposals for both sub-groups. Offerors are required to propose and properly substantiate pricing on all items in the Schedule of Items for each Group on which it offers. Failure to do so may result in its proposal being deemed technically unacceptable and therefore excluded from further consideration for award. Because the Contracting Officer is not obligated to initiate negotiations, each offeror shall submit its most competitive proposal for each Group it has chosen to propose on. Said proposal shall be responsive to all of the Solicitation's requirements and free from any deficiencies"

"The aforementioned zone is comprised of three (3) Groups in the Upper New York Zone. Group 1 consists of Non-DoD USDA Schools West (1a) and Non-DoD USDA West Reservation (1b) customers located in the Upper New York Zone. The Agency intends to award one separate contract per Group. Offerors may submit a proposal for any single group or multiple groups. The offeror must support all of the customers in the Group for which they make an offer. In regards to Group 1 (1a and 1b) and Group 3 (3a and 3b), the offerors must submit bid proposals for both sub-groups. 5. The Chart on Page 9 of Solicitation SPE30022R0049 displaying the dollar value of this acquisition has been changed. Group 3 Upper New York East Schools will now be Group 3 Upper New York East Schools and Reservation.

6. Page 41 paragraph 3 (h) of the Addendum to 52.212-1 of Solicitation SPE30022R0049 has been changed "The Government intends to make three (3) awards, one (1) for each Group based on the technically acceptable offer with the lowest aggregate evaluated price. The Government reserves the right to award more than one Group and up to three (3) Groups to one offeror if that offeror is the lowest price, technically acceptable offer for each group. In the event that one offeror is the awardee for three Groups, the Groups may be issued under a single contract. Offerors shall submit their best proposal for each Group independently due to the Government's right to make separate awards for Groups 1 (1a & 1b), 2, and 3. Offerors are required to offer on and properly substantiate pricing for all items in the Schedule of Items for each Group offered on; failure to do so may result in exclusion from award consideration."

Has been replaced with:

"The Government intends to make three (3) awards, one (1) for each Group based on the technically acceptable offer with the lowest aggregate evaluated price. The Government reserves the right to award more than one Group and up to three (3) Groups to one offeror if that offeror is the lowest price, technically acceptable offer for each group. In the event that one offeror is the awardee for three Groups, the Groups may be issued under a single contract. Offerors shall submit their best proposal for each Group independently due to the Government's right to make separate awards for Groups 1 (1a & 1b), 2, and 3 (3a and 3b). Offerors are required to offer on and properly substantiate pricing for all items in the Schedule of Items for each Group offered on; failure to do so may result in exclusion from award consideration."

For Group 1b, Reservation customers in the Upper New York zone, fill in Delivered Price (including Freight) cells G7 to G30. For Group 2, Troop customers, fill in Delivered Price (including Freight) cells G7 to G38. For Group 3, Schools East customers, fill in Delivered Price (including Freight) cells G7 to G32. The offeror may propose different Distribution Prices for each Group and for each Tier, but all items within each Tier shall have the same distribution price. The offeror must submit Tier period Distribution Prices by filling in cells H7 for Base 1, M7 for Tier 1, N7 for Tier 2 for Groups 1 (1a and 1b), 2, and 3 in Attachment 1. The spreadsheet will automatically calculate your total evaluated price for each Tier. All prices must be rounded to two places to the right of the decimal point using standard rounding methods (see paragraph A.2. above).
