***Question:*** Can the submarine piers can accept a 53' trailer for deliveries?  
***Answer:*** Yes they can.

***Question:*** Will the contractor be required to load the product onto the subs or can they simply offload onto the pier?  
***Answer:*** The contractor is not required to load product onto the submarines, they are required to offload onto the pier (Please reference page 69 Palletization, paragraph A).

***Question:*** Would you please clarify how many delivery days per week are expected for the Naval Submarine Base at New London?  
***Answer:*** The Sub base gets five deliveries per week.

***Question:*** For each Navy Ship listed when they are in port, how many deliveries per week would each expect?  
***Answer:*** The ports listed are for visiting ships including NAVY, NOAA, and CG. The NOAA and CG ships listed on the spreadsheet are home ported in the region, hence the regular delivery schedule. The Navy Subs are also home ported and also have a regular delivery schedule. The PORTS are for all visiting ships (NAVY, NOAA, and CG) and deliveries are as needed depending on the schedule of the visiting vessel.  
All other customers listed on the delivery schedule are regular customers. There are two NAVY Galleys, the USS Constitution (which is a non-moving ship), several ANG units, the AF Child development and CDC, the Marine Corp Reserves, the home ported CG and NOAA ships.

“Data Universal Numbering System+4 (DUNS+4) number” means the DUNS number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional CCR

records for identifying alternative Electronic Funds Transfer (EFT) accounts (see the FAR at subpart 32.11) for the same concern.

“Registered in the CCR database” means that—

(1) The Contractor has entered all mandatory information, including the DUNS number or the DUNS+4 number, into the CCR database; and

(2) The Government has validated all mandatory data fields, to include validation of the Taxpayer Identification Number (TIN) with the Internal Revenue Service (IRS), and has marked the record “Active”. The Contractor will be required to provide consent for TIN validation to the Government as a part of the CCR registration process.

(b) The Contractor is responsible for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government’s reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis, from the date of initial registration or subsequent updates, its information in the CCR database to ensure it is current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(i) If a Contractor has legally changed its business name, doing business as name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day’s written notification of its intention to—

(A) Change the name in the CCR database;

(B) Comply with the requirements of subpart 42.12 of the FAR; and

(C) Agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor shall provide with the notification sufficient documentation to support he legally changed name.

Assignees, shall be separately registered in the CCR database. Information provided to the Contractor’s CCR record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the “Suspension of Payment” paragraph of the EFT clause of this contract.
