1. Page 2, paragraph I.1.A. first sentence, the word "visiting" has been deleted and replaced with "Navy Ships Customers Only".

2. Page 2, paragraph I.1.D., second sentence has been revised to the following:

This contract will have a base period of up to twenty-seven (27) months, which includes an up to a three (3) month implementation period, and one (1) option period of twenty-four (24) months.

3. Page 3, first paragraph, last sentence, "s" has been added to "period".

4. Page 20, paragraph I.3.C, last sentence, "the" has been added in between "by Contracting".

5. Page 22, paragraph I.13, "." has been added after the number 13.

6. Page 22, paragraph i.13.J, first sentence, reference to "I.14" has been deleted and replaced with "I.13".

7. Page 22, paragraph I.13.J, second sentence, "\$7 Million" has been deleted and replaced with "\$1,750,000".

8. Page 22, paragraph II.A, 2nd sentence, reference to "(Paragraph M, below)" has been deleted and replaced with "(Paragraph L, below)".

9. Page 25, paragraph III.L, has been deleted in its entirety as palletization language appears on page 26.

10. Page 25, paragraph III.M, "M. FEDERAL FOOD, DRUG AND COSMETIC ACT-WHOLESALE MEAT ACT" has been deleted and replaced with "L. FEDERAL FOOD, DRUG AND COSMETIC ACT-WHOLESALE MEAT ACT".

11. Page 26, paragraph III. PALLETIZATION, the following sentence has been added to the first paragraph:

"Additionally, fragile cases must not have cases above them, but can have them beneath. For example, eggs are

14. Page 50, paragraph VI.2 ORDER LEADTIMES, the subparagraph has been re-formatted from "A, C, D" to "A, B, C".

15. Page 61, paragraph VI.11.A Holidays, "-ed " has been added to the word "cover" in the paragraph "***To ensure customers are cover...".

16. Page 63, paragraph VI.15.(C)(5) and (6), space corrections have been added.

17. Page 67, paragraph VII.3.B, third sentence: "the" has been changed to "The".

All other terms and conditions remain unchanged.
