2. Cells that are black & will not change include Line 102, column D.

DLA Response: Cell is unlocked.

3. Alternate cannot be changed for Line #95, column D

DLA Response: Column D is locked. Complete Column G on ITEM INFORMATION tab "Alternate Y or N?" Column D will then be populated.
