The solicitation is amended as follows:

1. Attachment 2 - Market Basket, which was previously revised in Amendment 0005, is further revised and attached to this Amendment 0008. This amended version supersedes previous editions. Changes to the spreadsheet are summarized below:

-On the first tab ("Totals"), cell C15 has been corrected to remove a redundant space that was preventing the totals to populate in cells F15, G15, and H15.

-On the second tab ("Market Basket"), for line item #34, the Unit of Measure (UOM) in Column D has been changed from LB to CS. As a result of the revised UOM, the Annual Quantities in Columns H and I for this line item were changed accordingly. In addition, the Evaluation Units per UOM (Historical) was changed from 54 to 52 to reflect the average case weight for this item. These changes were necessary to correct a mathematical error in the extended totals for this line item.
