The Solicitation is amended as follows:

1. The following paragraph is added under "ADDENDUM TO FAR 52.212-1- INSTRUCTIONS TO OFFERORS -- COMMERICAL ITEMS" - Price Proposal/Pricing", (b) General submission requirement information:

(v) DLA Troop Support was advised that in February 2018 the Government of Somalia instituted a new Value Added Tax ("VAT"), which applies across a range of transactions conducted within the nation including importing of goods. DLA is currently seeking a resolution of the Somalia VAT situation, specifically a waiver for all transactions involving subsistence good bound for the US Military customers. However this situation is only partially resolved. The VAT is not being applied to goods for DLA customers but it may be applied to service-related transactions. Offerors should therefore be award of this situation and its current status.

In regard to this issue please also refer to the Statement of Work in Amendment 001, page 69, section VI. ("INTERNATIONAL AGREEMENTS, WORKERS COMPENSATION INSURANCE, AND INTERPERTATIONS/TRANSLATIONS", paragraph A ("INTERNATIONAL AGREEMENTS (e.g. Defense Cooperation Agreement, Diplomatic Notes, Status of Forces Agreement (SOFA), etc.").
