Contract SPE300-18-D-4032 has been the subject of various bid protest litigation since the initial contract award, including several ongoing cases at the Court of Federal Claims. As a result, a stop work order has been in place under contract SPE300-18-D-4032 since January 30, 2018.

In order to expedite a full transition under this contract once litigation has completed, KGL Food Services WLL ("KGL") and DLA agree to begin limited implementation/ramp-up/transitions efforts while the bid protest litigation proceeds at the Court of Federal Claims (hereinafter a "soft transition"). KGL and DLA agree that, in order to avoid prejudice to the ongoing litigation proceedings and to reduce the cost of the soft transition, the soft transition efforts will not include KGL ordering product, receiving transfer of incumbent stock, receiving customer orders, or delivering customer orders under contract SPE300-18-D-4032. This soft transition will, however, include other implementation actions contemplated by contract SPE300-18-D-4032.

As part of this agreement to begin a soft transition, KGL agrees to waive all claims against the Government associated with costs incurred as a result of KGL's soft transition, including any and all termination costs associated with a termination for convenience, if and only if such termination would become necessary as a result of the outcome of any bid protest litigation.

Performance of this soft transition is subject to a formal lifting of the stop work order under SPE300-18-D-4032. KGL shall abide by the terms of any future stop work order issued under contract SPE300-18-D-4032. Any performance under contract SPE300-18-D-4032 that exceeds the scope of the soft transition discussed in this modification, including full transition efforts, may only begin if specifically authorized by a future modification to contract SPE300-18-D-4032.
