Reference is made to Modification P00001 to KGL's Subsistence Prime Vendor (SPV) Iraq, Jordan, Kuwait, Syria (IJKS) Contract, Contract No. SPE300-18-D-4032, effective March 12, 2019.

On March 13, 2019, DLA Troop Support lifted the Stop Work Order under KGL's SPV IJKS contract and authorized the commencement of a "soft transition" while bid protest litigation proceeds at the Court of Federal Claims. This soft transition did not include KGL ordering product, receiving transfer of incumbent stock, receiving customer orders, or delivering customer orders; however, it included other implementation actions contemplated by its contract.

Consistent with DLA Troop Support's notification to the Court of Federal Claims on April 8, 2019, in addition to its ongoing soft transition efforts, this modification hereby authorizes KGL to begin its full transition under its SPV IJKS Contract. Although full transition efforts are authorized, KGL shall not begin receiving customer orders or performing deliveries under the contract until specifically authorized by the Contracting Officer through a future modification to this contract. KGL shall also abide by the terms of any future stop work order issued under contract SPE300-18-D-4032.

All other terms and conditions of the contract remain the same.
