1. The purpose of this modification is to change the lead times in subsection XVI., (D) of the Statement of Work.

2. Contract SPE300-25-D-4006 is hereby modified as follows:

-Orders shall provide the following lead time for Philippines:

- Land Customers

- Land customers located in outer islands, including Zamboanga - 14 Days

- Land customers located in Luzon - 7 Days

- All other land-based customers - Skip Day (48 hours)

- Market Ready (highly perishable, FF&V) - 72 hours for regular orders

- Small Ships (SUBS, Mine Sweeps and LCS) Routine Daily Orders - Skip Day

- Small Ships (SUBS, Mine Sweeps and LCS) Deploying (from home port) - 7 days

- Large Decks (CVN/L Decks) Routine Daily - Skip Day (Currently there are no home port ships in the Philippines)

- Large Decks (CVN, /L Decks, LHAs, LHDs, CSGs, ESGs, Amphibious Ships (LHDs, LHAs, LCCs, LSDs) and CLF Ships)

Deploying (from home port) - 30 Days

- Transient (Visiting, Non-home port) Ships - 30 days

Note: Routine Daily orders are for home ported or permanently stationed ships.
