1. Administrative catalogs and customers on SPE300-25-D-PA05 (Central Florida Troops), and SPE300-25-D-SA29 (Central Florida Schools) are officially removed from this contract.

2. The following Place of Performance has been removed from this contract: Fresh One 6422 Harney Road, Tampa Florida 33610.

3. A new administrative catalog has been added to the contract which will be used to provide Shell Eggs for Troop customers in the Puerto Rico AOR per requirements in the Statement of Work, XXVII. Product Quality C. The new administrative catalog is SPE300-26-D-UA01. Ordering will commence on Monday, January 12, 2026, with first orders being delivered on Wednesday, January 21, 2026.

4. Modification to Statement of Work, XIII, B for catalog SPE300-26-D-UA01 only: Troop customers shall place their orders to accommodate at a minimum a 9-day lead time for Shell Eggs. For example, an order placed on Monday, January 5th would have a delivery date of Wednesday, January 14th.

5. Modification to Statement of Work, XIII, E (listed incorrectly as a second C) for catalog SPE300-26-D-UA01 only: Once submitted through the applicable electronic ordering system (i.e. STORES or FFAVORS), an order may be cancelled by a customer up to 72 hours before scheduled delivery via written notification to the Contractor and the Contracting Officer. Within less than 72 hours from delivery, an order may be cancelled by mutual agreement between the customer and the Contractor. In the event of an act of God, such as extreme weather, the specific situation regarding a cancelled delivery will be dealt with in an equitable manner by the Contracting Officer, who has the ultimate authority and discretion to resolve said issues.

6. All other terms and conditions of the contract remain unchanged.
