1. On page 1 of Standard Form 1449, in box 10, remove Set Aside 100% for small business and replace with Unrestricted.

2. Remove the following paragraph from page 8 of solicitation:

C.This solicitation is being issued as 100% Small Business set-aside acquisition under full and open competition procedures. NAICS is 311991 and size standard is 500. In accordance with 13 CFR 121.406(d), the nonmanufacturer rule does not apply to this acquisition because the dollar value falls between the micro-purchase threshold and the simplified acquisition threshold.

And replace with:

C. This solicitation is UNRESTRICTED.

3. Remove the following paragraph from page 21 of the solicitation:

A. The minimum order requirement for any resultant contract is \$150.00. This requirement shall be based on the aggregate total of orders for a specific delivery date to all customers located within a particular military base or delivery location.

And replace with:

A.The minimum order requirement for any resultant contract is \$300.00. This requirement shall be based on the aggregate total of orders for a specific delivery date to all customers located within a particular military base or delivery location.
