1. Remove and replace Section I. Introduction, paragraph B. from page 8 of the solicitation with the following language:

B. The aforementioned zone is comprised of (1) Group in the area described above. Group 1 consists of customers located at and/or in NAS Key West, and USCG Miami, Florida. Group 1 contract period is expected to be from November 1, 2020 through November 4, 2023. The Agency intends to award one contract per Group. The offeror must support all of the customers in the Group for which they make an offer. Offerors are required to propose on all items in the Schedule of Items. Failure to do so may result in its proposal being deemed technically unacceptable and therefore excluded from further consideration for award. Because the Contracting Officer is not obligated to initiate negotiations, each offeror shall submit its most competitive proposal. Said proposal shall be responsive to all of the Solicitation's requirements and free from any deficiencies.

2. Remove and replace Section II. Effective Period of Contract, paragraph A. from page 8 of the solicitation with the following language:

A. Any resulting contract from this Solicitation will not exceed 3 years commencing on the effective date of November 1, 2020.

3. Remove and replace "Attachment 1 - Schedule of Items-R0040" with "Attachment 1 - Schedule of Items-0040-Revised".

4. The solicitation closing date has been extended to September 30, 2020.

5. All other terms and conditions remain unchanged.
