## MINIMUM NUTRITIONAL REQUIREMENTS

- White bread/rolls and other items (except wheat items): All sliced bread offered should contain fewer than 230 milligrams of sodium per serving when available fortified with iron and folate is preferable.
- B. Wheat bread/rolls: All sliced bread offered contains whole grains (white with whole grains or whole wheat with at least 2.5 grams fiber per serving) with fewer than 230 milligrams of sodium per serving when available and fortified with iron and folate is preferable.
  - C. Bagels: Must be hearth baked and made from enriched grains.
    D. English muffins: Must be made from enriched grains.
