SECTION I - Solicitation Amendment for Georgia

1. Attached is a further revised Quote Spreadsheet and Invoice Summary Spreadsheet. Attachments 1 and 2 of Amendment 0006 are hereby replaced by these two spreadsheets, respectively.
2. The Quote spreadsheet has been updated. Column M has been revised from "Start Date of First Military Rebate/Discount/Deviation" to "Begin First Military Rebate/Discount/Deviation" and Column Q has been revised from "Start Date of First Other Rebate/Discount/Deviation" to "Begin First Other Rebate/Discount/Deviation".
3. The Invoice Summary Spreadsheet has also been updated. Column K has been revised from "Start Date of First Military Rebate/Discount/Deviation" to "Begin First Military Rebate/Discount/Deviation" and Column O has been revised from "Start Date of First Other Rebate/Discount/Deviation" to "Begin First Other Rebate/Discount/Deviation".
4. The instructions for the Quote spreadsheet on page 11 of Amendment 0006 are revised as follows:
Delete: M. START DATE OF FIRST MILITARY REBATE/DISCOUNT/DEVIATION - i.e. First Order or specific date
Replace with: M. BEGIN FIRST MILITARY REBATE/DISCOUNT/DEVIATION - i.e. First Order or a number of days after the first order, e.g., "first order + 60 days.

Delete: M. NO. OF DAYS FIRST MILITARY REBATE/DISCOUNT/DEVIATION IS VALID - The number of days that an offered rebate/discount/deviation is valid. This block should match the number of days entered in Column Q on the ITEM INFORMATION Tab of the Price Proposal Spreadsheet.

Replace with: N. NO. OF DAYS FIRST MILITARY REBATE/DISCOUNT/DEVIATION IS VALID - The number of days that an offered rebate/discount/deviation is valid. This block should match the number of days entered in Column Q on the ITEM INFORMATION Tab of the Price Proposal Spreadsheet.

(The letter "M" was replaced with the Letter "N")

Delete: Q. START DATE OF FIRST OTHER REBATE/DISCOUNT/DEVIATION - i.e. First Order or specific date

Replace with: Q. BEGIN FIRST OTHER REBATE/DISCOUNT/DEVIATION - i.e. First Order or a number of days after the first order, e.g., "first order + 60 days.

5. The instructions for the Invoice Summary spreadsheet on page 12 of Amendment 0006 are revised as follows:

Delete: K. START DATE OF FIRST MILITARY REBATE/DISCOUNT/DEVIATION - i.e. First Order or specific date

Replace with: K. BEGIN FIRST MILITARY REBATE/DISCOUNT/DEVIATION - i.e. First Order or a number of days after the first order, e.g., "first order + 60 days.

Delete: O. START DATE OF FIRST OTHER REBATE/DISCOUNT/DEVIATION - i.e. First Order or specific date

Replace with: O. BEGIN FIRST OTHER REBATE/DISCOUNT/DEVIATION - i.e. First Order or a number of days after the first order, e.g., "first order + 60 days.

All other terms and conditions remain unchanged.

SECTION II - Questions and Answers

The answers in Section II are provided for clarification purposes only and do not change the solicitation requirements. In the event of any discrepancy between the answers provided in Section II and the solicitation documents, the solicitation documents will take precedence.

1. Question: Per the solicitation instructions regarding the Price Proposal spreadsheet, the Quote Spreadsheet and Invoice Summary Spreadsheet: Item Information Tab (page 5 of Amendment 0006): "Q. NO. OF DAYS FIRST MILITARY REBATE/DISCOUNT/DEVIATION IS VALID: (Offeror fill in) The number of days that an offered rebate/discount/deviation is valid. This field must be completed only if column P is marked with a Y. PLEASE NOTE: Any rebate/discount/deviation offered must be valid starting with the first delivery order. The first delivery order starts after implementation period is complete."
The date (or evaluation date) for the first order is not defined. It seems that without an established evaluation "first order date", the price evaluation may not be equally objective for all offerors.

Answer: Offered rebates/discounts/deviations will be considered during evaluations only to the extent that the rebate/discount/deviation will be valid during the performance period of the contract and only for the number of days that the rebate/discount/deviation will be valid. Rebates/discounts/deviations described as being valid for specified dates, i.e. described with beginning and ending dates, will not be considered during evaluation. Any offered rebates/discounts/deviations must be effective during the ordering period of the contract in order to be evaluated. The instructions for the quote spreadsheet will be updated to revise Column M from "Start Date of First Military Rebate/Discount/Deviation" to "Begin First Military Rebate/Discount/Deviation" and Column Q from "Start Date of First Other Rebate/Discount/Deviation" to "Begin First Other Rebate/Discount/Deviation". These columns should be completed with the phrase "first order" or a number of days after the first order, e.g., "first order + 60 days". The instructions for the invoice summary spreadsheet will be updated to revise Column K from "Start Date of First Military Rebate/Discount/Deviation" to "Begin First Military Rebate/Discount/Deviation" and Column O from "Start Date of First Other Rebate/Discount/Deviation" to "Begin First Other Rebate/Discount/Deviation". These columns should be completed with the phrase "first order" or a number of days after the first order, e.g., "first order + 60 days".

2. Question: Please reference the provision in the solicitation that states that rebated/discounted/deviated unit prices, as shown on the Quote and Invoice Summary Spreadsheets, may not be adjusted under the contract EPA clause for the number of days/time period as quoted.

Answer: Clause DLAD 52.216-9064 ECONOMIC PRICE ADJUSTMENT (EPA) - ACTUAL MATERIAL COSTS FOR SUBSISTENCE DELIVERED PRICE BUSINESS MODEL - DLA TROOP SUPPORT SUBSISTENCE PRIME VENDOR (SPV) CONTIGUOUS UNITED STATES (CONUS), ALASKA, AND HAWAII (APR 2014) discusses how prices will be adjusted under the resulting contract.
