Item Information Tab" Line #44 Column "J" is LB and Column "M" is CS and Column "N" as 1. Column "J" remains LB, Column "M" has been changed to LB and Column "N" to 10.

1. Question: Georgia Only

It appears there is an incorrect formula of the NAPA column for Market Basket line item 94. This formula needs a correction. Please advise.

Answer

The "Item Pricing Tab" line number 93 and 94 Column M and N has been updated with the proper formula for correct calculations.

2. Question: Georgia Only

On line 35 it lists Gravy mix, BRN 6/13 oz "Evaluation Unit of Measure" Column "M" at EA (#10CN) with 6 per case. The understanding is that gravy mix is a mandatory item from CW Resources and should be LSN 8940-01-E62-4753. Please advise.

Answer:

The "Item Information Tab" Line number 35 gravy mix brn 6/13 Column "M" titled Evaluation Unit of Measure states EA (#10cn) with 6 per case. Column "M" has been changed to EA (13 oz) with 6 per case. The Market Basket has historical items listed which does not constitute the current catalog.

3. Question: Georgia Only

Looking at line 44 of the market basket, "ITEM INFORMATION TAB" COLUMN "J" AS LB AND THE COLUMN "M" AS "CS" WITH COLUMN "N" AS 1. I believe column "N" should be 10, Please advise.

Answer:

The "Item Information Tab" Line number 44 Column "J" as LB and Column "M" titled Evaluation Unit of Measure states CS and Column "N" as 1. Column "M" has been changed to LB and Column "N" to 10.
