The answers below are provided for clarification purposes only and do not change the solicitation requirements.

The estimated dollar value shown on page 88 of Solicitation SPE30024R0012 is based on the annual sales usage of the region, as well as a projection of what DLA expects the annual sales usage to be over the life of the resulting contract. The chart referenced on pages 89-90 of the solicitation, however, is not an estimate of customer sales for Solicitation SPE30024R0012, but an estimate of historic customer sales from the period of January 1, 2022, to December 31, 2022, under contract SPE30020d3260. Due in part to item shortage issues as a result of COVID-19, the estimates contained in the chart are significantly higher than what DLA estimates the sales usage will be going forward under Solicitation SPE30024R0012. An amendment will be issued further clarifying this discrepancy.

We want to clarify that solicitation number SPE30023R0030 was replaced with solicitation number SPE30024R0012.

All of the remaining solicitation requirements remains unchanged.

Solicitation closing date was extended to April 9, 2024.
