Paragraph 2(b) any order for a combination of items in excess of 10% of the award estimated dollar value has be change to 25%.

Pricing for all other terms will have separate pricing tiers and the pricing will remain firm-fixed for each pricing tier. The first pricing tier shall begin on the award date and be for a 24 month period (September 28, 2014-September 24, 2016 , has been change to September 24, 2017-September 21, 2019. The second pricing tier shall be for the following 12 month performance period (September 25, 2016 - September 23, 2017 has been change to September 22, 2019- September 19, 2020. The effective period for any contract resulting from this solicitation shall be from September 28, 2014 through September 23, 2017 has been change to September 24, 2017 through September 19, 2020.
