


Contract SPE300-14-D-3037 is hereby modified as follows:

The second option for a twenty-four (24) month period under subject contract is hereby exercised. The Option period Sunday, September 3, 2017 through Saturday, August 31, 2019; a period of 728 days. The estimated dollar value of the second option is \$4,719,662.00. The contract maximum dollar value, including all options, is \$17,100,775.00 (150%). This option has a guaranteed minimum value of \$1,179,916.00 (25%). The distribution prices for all items during this option period will remain unchanged from the base period.
