The following provides answers to questions which were submitted in regards to Solicitation SPM300-14-R-0002. The answers are provided for clarification purposes only and do not change the requirements in the solicitation.

- 1. Vendor Question:** Will the over-ocean freight charge Offerors enter in the spreadsheet (for A and B category items) be a fixed-fee amount that is added to the FOB consolidation point to arrive at the delivered to distributor (landed) price?

DLA Troop Support Answer: The over-ocean transportation price that the offerors propose in the spreadsheet for Categories A (Frozen / Chill) and B (Dry) will be a firm fixed price portion of the Contract Unit Price. The over-ocean transportation price is defined under the Distribution Price definition. See Amendment 0007 #2.

- 2. Vendor Question:** Is the Offeror required to service the Coast Guard customers in Southeast Alaska (Juneau area)?

DLA Troop Support Answer: Yes, the offeror is required to service the Coast Guard customers in Southeast Alaska under Zone 4 (i.e. 4B). See Amendment 0002 #1 and Amendment 0008 #7.

- 3. Vendor Question:** Must the Distribution Price for moving products from Alaska to the customer delivery points include ALL COSTS, including tote preparation, labeling and third-party freight charges?

DLA Troop Support Answer: Yes, please refer to solicitation page 52-53 for the definition of Distribution Price (i.e. Group II Distribution Price and Group III Distribution Price). See Amendment 0008 #3 and #4 for buyer fill-in information for Group II and Group III Distribution Prices.
