For items produced with shelf life less than 90 days, no product shall be delivered to customers with less than 5 days manufacturer's original shelf life remaining unless the customer grants prior written approval to the Contracting Officer who will in turn notify the Contractor(s)." Is being replaced with "2. PRODUCT QUALITY & SHELF LIFE REQUIREMENTS A. Shelf life requirements: 3. For items produced with a shelf life of less than 90 days, no product shall be delivered to customers with less than five (5) days of the manufacturer's original shelf life remaining. Furthermore, for all perishable Dairy products, the Contractor shall check all "use by," "best by," "sell by," or expiration dates daily to ensure a minimum of five (5) days of shelf life remains, inclusive of the delivery day. An exception to this five-day minimum for any product may only be granted if the customer provides prior written approval to the Contracting Officer, who will in turn notify the Contractor."
