2. BACKGROUND:

Mondelez Global LLC announced today a voluntary recall in the United States of the Green & Black's Organic Peanut & Sea Salt Milk Chocolate Bar. This product contains peanuts supplied by Sunland, Inc., which expanded its nationwide recall on October 12, 2012. The peanuts have the potential to be contaminated with Salmonella, which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with Salmonella often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with Salmonella can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.

This recall is limited exclusively to the Green & Black's Organic Peanut and Sea Salt Milk Chocolate Bar (UPC 708656100562, 3.5 oz. bar, all "best by" dates) manufactured and sold only in the United States, available at retail and specialty stores nationwide. No other Green & Black's product is included in this recall.

Consumers who have this product should not eat it, and should discard any products they may have.

There have been no complaints of illness reported to Mondelez Global to date in connection with this product and the company is issuing this recall as a precaution.

a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use.

POSITIVE FINDINGS should be reported to Accountable Officers/Vendor Representatives of that facility. Accountable Officer/Agency representatives/Buyers/Contracting Officers should seek/refund/credit/replacement through the normal distribution channel with which the product was received (i.e. Distribution Centers, Prime Vendors, or Manufacturers).

- b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. In order to get credit please use a SF 364 and forward to your supporting NAVSUP Fleet Logistics Center (NAVSUP FLC) and copy furnished to NAVSUP 51. Your supporting NAVSUP FLC should forward to the account manager at DLA Troop Support. The form should include the number of the recall authorizing the survey action. Home-ported ships/galleys will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.
