a. REMARKS:

(1). ALFOODACT 130-2009 and ALFOODACT 131-2009 are CLOSED but are reference material for ALFOODACT 139-2009.

(2). ALFOODACT 139-2009. The Dairyshake Powder Do Not Consume Order remains in effect until all potentially affected stocks are exhausted. Troop Support has established 1 June 2013 as the tentative end date for ALFOODACT 139-2009, based on MRE three year shelf life plus one year. Troop Support has established an "OPERATIONAL RATIONS, DAIRYSHAKE POWDER, INFORMATION PAGE"

ALFOODACT 130-2009 and ALFOODACT 131-2009 are CLOSED but are reference material for ALFOODACT 139-2009.

(3). ALFOODACT 010-2011 Update to ALFOODACT 004-2011 Suspension Removal for Food Procurement from Specified Regions and Prefectures of Japan. This ALFOODACT message will remain "OPEN" until August 7, 2012. DLA -Troop Support launched a webpage listing establishments in the Japan Suspension Zone that have successfully completed enhanced testing, verification, and validation of food production facilities. The webpage is a dynamic document and will be updated when facilities are validated and approved for DoD procurement. Procurement agencies/contracting officers should refer to the webpage frequently to view current data. No further announcements of facility listings or delisting will be issued via the ALFOODACT system.

(4). ALFOODACT 034-2011, 036-2011, 034-2011, and 044-2011. Dimethylamylamine (DMAA) Is Placed On Medical Hold Due To Possible Serious Adverse Health Effects remains "OPEN". As the Office of the Secretary of Defense (OTSD), the Office of Surgeon General OTSG, United States Food and Drug Administration (FDA), and the Department of Defense Veterinary Service Agency (DODVSA) continue the review of 1,3-dimethylamylamine (Dimethylamylamine, DMAA, etc.), all ALFOODACT messages associated with the original message will remain "OPEN" until an official determination for disposition is made and a follow up ALFOODACT message is issued.

b. Closed status denotes that this office has provided final disposition instructions for the item(s).

c. Open status denotes that only partial disposition instructions have been provided, and that further instructions will be provided in a subsequent message by this office.

4. ALFOODACT messages may involve situations of serious adverse health consequences or death. Therefore, it is important for each message recipient to carefully read each ALFOODACT Message in detail and take appropriate action expeditiously. Message recipients should take the appropriate and necessary follow-up actions for subsequent deliveries of the recalled item(s) to ensure compliance with the initial recall.

5. To avoid delays, recipients of ALFOODACT Messages are encouraged to maintain a close liaison with their servicing telecommunications centers. The installation message center must be provided with a current point of contact list within the activity to ensure timely notification of receipt. If an ALFOODACT Message is not received, the local telecommunications center should be contacted to obtain a copy. However, if all attempts to secure a copy fail, then contact this center (DLA-FTW) for further assistance.

Reference 1.b. requires telecommunications centers to maintain a file of each ALFOODACT Message for one year and to provide copies upon request. Paragraph 309 of reference 1.b. further requires the telecommunications centers to maintain a record of each joint general message (e.g., ALFOODACT Messages) by serial number, until canceled by the first ALFOODACT Message of the new calendar year. If the telecommunications center failed to receive the message, then they should request a retransmission from their particular switching station. This center is responsible for issuing ALFOODACT Messages. Message recipients that have not received a message for 90 days or longer can access Troop Support's Food Safety Office web page for the latest message. <http://www.troopsupport.dla.mil/subs/fso/alfood/afamess.asp>

6. Activities that discover a condition in a food or nonprescription drug that may require a recall should report it to DLA Troop Support Philadelphia, PA//DSCP-FTW// IAW paragraph v.d.5 of reference 1.a. While an activity may place an item on "Medical Hold" for a hazardous condition, the issuance of an ALFOODACT Recall Notice is restricted to the DLA Troop Support Consumer Safety Officer.

7. Disposition instructions are currently being placed below the body of each message and can be interpreted as follows:

a. Messages which state, "the item is to be placed in a "Medical Hold" status and the particular supplier/distributor contacted for appropriate disposition instructions," will indicate that no further disposition instructions will be provided by this center, and the action will be considered closed.

b. Only messages, which state, "the item is to be placed in a "Medical Hold" status and appropriate disposition instructions will be issued at a later date," will be considered open, and further instructions will be provided by this center.

8. Troop Support appreciates the outstanding efforts and continued support of the DoD Hazardous Food & Nonprescription Drug Recall System by all activities during 2012. Your comments and suggestions for improvement to this system are always welcomed.
