SUBJECT: ALFOODACT 2016-015: **Back to Nature LLC Recalls Limited Number of Classic Creme Cookies (undeclared milk)**

Date Issued: April 20, 2016

2. BACKGROUND:

Back to Nature Foods, LLC recalls lots of its Classic Creme cookies, 12 oz packages, because they may contain undeclared milk, not listed as an ingredient on the label.

3. PRODUCTION DATES/IDENTIFYING CODES: The affected product was distributed to retail stores nationwide. Previously recalled item: Unit **UPC# 19898-01103** with **best by dates of 10 SEP 16 and 16 SEP 16** labeled on top of the package. Presently recalled item: Classic Creme cookies packages marked with a unit **UPC# 19898-01103** and with **best by dates of 13 AUG 16 and 08 OCT 16 and 21 OCT 16 and 22 OCT 16** labeled on top of the package were also affected. Undeclared Allergen

7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

- a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use.

POSITIVE FINDINGS should be reported to Accountable Officers/Vendor Representatives of that facility. Accountable Officer/Agency representatives/Buyers/Contracting Officers should

seek/refund/credit/replacement through the normal distribution channel with which the product was received (i.e. Distribution Centers, Prime Vendors, or Manufacturers).

b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion.

Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. In order to get credit please use a SF 364 (For instructions on how to "Properly Prepare a Standard Form" (SF) 364 please use this link [<http://www.dla.mil/LandandMaritime/Offers/Services/TechnicalSupport/Logistics/Packaging/PrepareSF364.aspx>]) and forward to your supporting NAVSUP Fleet Logistics Center (NAVSUP FLC) and copy furnished to NAVSUP 51. Your supporting NAVSUP FLC should forward to the account manager at DLA Troop Support. The form should include the number of the recall authorizing the survey action. Home-ported ships/galleys will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.

c. DLA Troop Support Subsistence Prime Vendors must report POSITIVE and NEGATIVE RESPONSES directly to their DLA Troop Support Contracting Officer with a courtesy copy to the Consumer Safety Officer (dscpconssafofc@dlamail).

d. DeCA, AAFES, MWR, VA, MCCS, or other non-DLA Troop Support agencies SHOULD NOT respond to the DLA Troop Support Consumer Safety Officer. These agencies should report POSITIVE and NEGATIVE responses in accordance with their agency recall policies.
