**SUBJECT:** ALFOODACT 2016-018: Ajinomoto Windsor Recalls Products Related to CRF Frozen Vegetable Recall (*Listeria monocytogenes*)

Because the recalled products contain vegetables that are part of the recent CRF Frozen Foods recall.

2. BACKGROUND:

Ontario, CA — Ajinomoto Windsor, Inc. is voluntarily recalling various Not-Ready-To Eat frozen food items due to the potential for these products to be contaminated with *Listeria monocytogenes*. This voluntary action is being undertaken in cooperation with the United States Department of Agriculture and the US Food and Drug Administration because the recalled products contain vegetables that are part of the recent CRF Frozen Foods recall.

*Listeria monocytogenes* is an organism that can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headache, stiffness, nausea, abdominal pain, and diarrhea, *Listeria* infection can cause miscarriages and stillbirths among pregnant women.

3. PRODUCTION DATES/IDENTIFYING CODES: In the following tables, all listed products with a Use-By Date of November 5, 2017 or earlier are impacted by this voluntary recall. If the product has a Julian Code Date, then remove/return/destroy that product as well, except for the listed Fred's Battered Green Beans and the Molly's Kitchen Battered Green Beans, use the codes listed in the table.

#### 6. REASON FOR ACTION:

Because the recalled products contain vegetables that are part of the recent CRF Frozen Foods recall.

#### 7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use.

POSITIVE FINDINGS should be reported to Accountable Officers/Vendor Representatives of that facility. Accountable Officer/Agency representatives/Buyers/Contracting Officers should seek/refund/credit/replacement through the normal distribution channel with which the product was received (i.e. Distribution Centers, Prime Vendors, or Manufacturers).

b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. Home-ported ships/galleys will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.

c. DLA Troop Support Subsistence Prime Vendors must report POSITIVE and NEGATIVE RESPONSES directly to their DLA Troop Support Contracting Officer with a courtesy copy to the Consumer Safety Officer ( [dscpconssafofc@dla.mil](mailto:dscpconssafofc@dla.mil)).
